 - a. The reply from UK Highway regarding initial urgency for the repair work to the motorway bridge at J5, did not answer the question. The clerk was asked to write again and request a copy of the second report. Stokenchurch Parish Council and the M40 CEG to be contacted and asked for the latest information they might have on this matter. Action clerk.
 - b. The Chairman read out the reply received from BCC re the proposed HGV signage. The type of sign they are proposing is not prescribed in the Traffic Signs Regulations so they are going through the authorisation process with DfT in order to gain their approval for the use of this particular sign. The clerk had asked for a description of the sign, but no response as vet.
 - c. The PC had received correspondence from Ivinghoe PC on excessive HGV traffic on unsuitable rural roads. They are compiling data to present to BCC. They have asked other Buckinghamshire parishes for their input. Members were happy for the clerk to pass on information. She was requested to check with Mr. Jones if the information he had supplied to the PC with regard to a HGV getting stuck in the village could be passed on. Action Clerk.
